Parade End:	Roseville Square's north lot behind Roseville Commons
Application Deadline:	Thursday, November 11, 2021
Awards:	Winners will be announced via website and may claim their trophy or ribbon after Thursday, December 1, 2021 at the Roseville Area Chamber of Commerce, 650 Douglas Blvd.

## **60th Annual Sylvia Besana Holiday Parade General Rules and Guidelines**

(Please read the rule and guidelines carefully before signing application)

**CHECK IN DETAILS:** Saturday, November 20<sup>th</sup> at 9:00 AM

Band and Horse Entries: Check in at The Rock of Roseville parking lot, 725 Vernon St., between Pratt St. and Bulen St. Horses line up on Pratt St. (not the actual parking lot) and Bands line up alongside The Rock on Bulen St. All other entries check in at 6<sup>th</sup> St. and Vernon St. Upon check in you will receive your parade number and your position will be assigned.

**PARADE START TIME/LENGTH:** 10:30 AM Sharp. The parade route is approximately 1.5 miles.

**ENTRY REQUIREMENTS AND SELECTION:** Entry applicants are all subject to approval by parade organizers. Entries must be accompanied by a complete entry form and entry fee, no later than Thursday, November 11, 2021. Entries arriving after the application deadline **MAY** be allowed in the parade but will be placed at the end of the parade. The parade is a “family friendly” celebration and parade participants must be appropriate to be seen by all ages. The parade will **NOT** be used as a platform for special interests.

**ENTRY APPLICATION FORM:** The entry application form must be completed and signed with the understanding of the general rules and guidelines. The parade organizers reserve the right to reject any entry at any time. Applicants will receive notification of their acceptance. Staging instructions will be sent approximately 10 days before the parade. Failure to abide by these rules and guidelines and those presented with the information package may result in the entry’s removal from the parade.

**\*GENERAL ENTRIES:** A fee of \$15 is required for each entry.

**\*COMMERCIAL/BUSINESS ENTRIES:** A fee of \$50 is required for each entry.

**\*EQUESTRIAN/LARGE ANIMAL UNITS:** A fee of \$15 is required for each entry.

**OFFICIAL SANTA CLAUS:** An official Santa Claus has been designated. No other Santa Claus will be permitted in the parade.

**FORWARD MOTION PARADE:** All entries are required to maintain a continuous forward motion during the parade. Those performing at the judging stand are required to complete their performance within one minute. The Judging Stand will be on the right-hand side of the parade route.

**NO TOSSING CANDY OR FAVORS:** No items can be tossed along the parade route due to littering and liability policies by the City of Roseville. Tossing any items from the parade route is a serious liability factor, one that has resulted in injuries in other parades.

**CANCELLATION POLICY:** Only a significant act of nature will cancel the parade. **THE PARADE WILL NOT BE RESCHEDULED.** In the event of a possible cancellation, please call the Parade Director at 916-

If, for some unseen reason, your entry is not able to participate in the parade after being accepted you must contact the Parade Director prior to the parade date. **No refunds.**

**PARADE JUDGING:** A panel of community judges will judge all qualifying entries. Judges decisions are final. Parade award winners will be announced Tuesday, November 30<sup>th</sup>, following the parade, and posted on the parade website ([www.sylviabesanaparade.org](http://www.sylviabesanaparade.org)).

**ALCOHOLIC BEVERAGES ARE NOR PERMITTED ON PARADE ROUTE**

**TYPES OF ENTRIES CONSIDERED FOR THE PARADE**

**MARCHING MUSICAL UNITS: School bands, Drum Corps, Independent Bands, etc.** Marching musical units are required to perform the one-mile parade route. Unit members are required to be in uniform attire. Holiday attire is encouraged.

**FLOATS:** We recommend push floats for this parade or decorated trailers. A description of the float design with size dimensions must be submitted with the parade application. Floats should not exceed 50 feet in length (including tow vehicle) or more than 14 feet in height and 10 feet wide.

**MARCHERS/SPECIALTY UNITS: Clowns, Color Guards, Marching Groups, Scouting Groups.** Units will be considered on their entertainment value or uniqueness. Entries required vehicles to carry sound systems must notify parade organizers on the application. Carts or vehicles accompanying the entry must be decorated.

**VEHICLES: Limit 24 vehicles per vehicle entry.** Vehicles considered for entry must be antique or unique or decorated. Commercial business vehicles such as vans, tankers, farm machinery, tractor-trailers and other large vehicles are not encouraged due to liability and safety concerns. Entrants must have full control of vehicles as all times.

**EQUESTRIAN/ANIMAL UNITS:** Equestrian riders should be at least 8 years of age and accompanied by an animal trainer. Any animal deemed unsafe in the parade will be removed. All animal units must provide their own "clean-up" crew and equipment to follow their unit in the parade. Entrants must have full control of animals at all times.

**DRILL/DANCE: Dance Troupes, Drill Teams, Baton Groups, etc.** should consist of 10 members or more to be considered. Routines must be choreographed for forward motion. Performance time at the judging stand must be within a 1-minute time limit.

**PARTICIPANT AGE RESTRICTIONS:** Walking participants must be at least six (6) years of age or older. There must be a least one adult escort for every 6 children under the age of 13 years. Young children riding on a float must have adult supervision on and around them.
